

Work safety coordination

Agreement on the coordination of work safety

concluded by and between

On the one hand Schaeffler Savaria Kft. (9700 Szombathely, Zanati u. 31.) as Client, *on the other hand*

..... as an external company regarding the **Contract/Order** for

declares that under the ordered work, it will fulfill the obligations of health and safety and fire protection regulations.

In course of the fulfilment of the **Contract/Order**, **Contractor** shall fulfil the obligations specified in Act XCIII of 1993 on Work Safety (hereinafter referred to as Work Safety Act) and in Decree No. 4/2002. (II. 20.) EüM-SzCsM, and shall take the necessary measures in its own company. Contractor shall be solely liable for the complete observance of the requirements to be observed at the building worksite and in course of the construction work processes.

The external company shall ensure that the occasional work with fire hazard has a permit in writing.

The external company is personally responsible for the fulfillment of the environmental, health and safety and fire protection obligations of the companies it subcontracts.

The external company shall maintain documentation on the subcontractor structure prevailing in respect of the construction site taken over by Contractor. The documentation should be able to clarify the situation in the event of a legal dispute.

The external company shall ensure that the employees participating in the construction may stay in the work are. They can leave it only in pre-agreed, justified cases.

The external company shall ensure that the employees participating in the construction stay in the worksites not handed over by Schaeffler Savaria Kft. as worksite only in previously arranged and justified cases.

The environmental protection, health and safety, fire protection team (EHS team) of Schaeffler Savaria Kft. may carry out EHS inspections at the construction worksite without notification. If any irregularity is found, then the EHS team shall contact the external company or the person assigned by, who shall take measures to terminate the irregularity found as soon as possible. If the irregularity directly and seriously threatens the health of anybody, or if the irregularity threatens to cause great financial or environmental damage, then the person conducting the inspection may act immediately, foregoing the external company and the agent thereof, and notifying them after the case. The external company, the subcontractors, as well as the

employees shall acknowledge the measure taken and shall act accordingly. If this fails to occur, then the inspecting person may stop the working operation until the termination of the irregularity! The external company must also inform the subcontractors or employees it employs of the right of control specified in the above paragraph. The right of inspection of Schaeffler Savaria Kft. does not affect the environmental, health and safety, fire protection liability of the external company!

If the violation of environmental, health and safety, fire protection rules is serious, Schaeffler Savaria Kft. reserves the right, through the person handing over the work area, to ban the company, employee, machine, equipment, technology, material from the site.

In the event of a serious, fatal accident or any kind of environmental pollution (eg accident) during the work on the construction site, the external company must immediately report the incident and the measures taken to the **head of the EHS** team.

The external company is also obliged to conclude this agreement in the direction of the companies it subcontracts, to acquaint and comply with its contents.
